

**AUDITOR'S REPORT ON COMPLIANCE WITH SECTION 22(1A) INCLUSIVE OF
THE ONTARIO COLLEGE OF TEACHERS ACT, 1996 - ONTARIO REGULATION
293/00, DATED MAY 20, 2010**

To Ontario College of Teachers

We have audited the Ontario College of Teachers' compliance as at April 8, 2015 with the criteria established for counting the 2015 Council elections as described in Section 22(1a) inclusive of the Ontario College of Teachers Act, 1996 - Ontario Regulation 293/00, dated May 20, 2010. Compliance with the criteria established by the provisions of the regulation is the responsibility of the management of the Ontario College of Teachers. Our responsibility is to express an opinion on this compliance based on our audit.

We conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we plan and perform an audit to obtain reasonable assurance whether Ontario College of Teachers complied with the criteria established by the provisions of the regulation referred to above. Such an audit includes examining, on a test basis, evidence supporting compliance, evaluating the overall compliance with these criteria, and where applicable, assessing the accounting principles used and significant estimates made by management.

In our opinion, as at April 8, 2015, the Ontario College of Teachers is in compliance, in all material respects, with the criteria established for counting of votes for the 2015 Council elections as described in Section 22(1a) of this regulation.
