Subject: Report of the Standards of Practice and Education Committee

Committee Meeting Dates

The Committee met on February 19, 2020.

Summary of Discussions

1. Chair's Report

The Chair welcomed Colleen Landers to the Committee.

The Chair shared the upcoming annual AQ supplement which will be included in the March 2020 edition of *Professionally Speaking/Pour parler profession*. In this year's annual AQ supplement, the College speaks with educators and stakeholders who have collaborated to develop Additional Qualifications (AQs) that support students with complex learning profiles. They are committed to ensuring that AQs are designed with the concepts of inclusivity, self-reflection, student voice and diversity in mind.

2. Overview of SP&E Budget

Roch Gallien, Director of the Standards of Practice and Accreditation department, provided an overview of the operational budget and work of the Standards of Practice and Education (SP&E) unit in relation to Objects 4, 6, 7 and 9. He explained that the committee budget will be presented and approved by the SP&E Committee at a future meeting after it has been prepared by Corporate Council Services.

The Director provided an overview of the development process for Additional Qualification (AQ) courses, beginning with initial background research and consultation required to develop AQ course guidelines, followed by developing the guidelines and finally accrediting AQ courses that provider's develop and submit based on the AQ course guidelines. The Director further spoke to the staffing in the unit and shared an organizational chart of the department. The department budget has been maintained since 2015, however the Director

explained that through efficiencies in streamlining efforts within the accreditation unit, he was able to transfer additional funds to the SP&E unit due to the significant increase in volume in the development of AQ course guidelines as well as the accreditation of AQ courses following a restructuring of the two units in 2015. A lengthy discussion ensued.

Committee members stressed the need for Council to have a more comprehensive understanding of the significance of the work of the SP&E Unit and the Committee.
